Eligibility of Contestants

Any Producer using 100% Golden Guernsey Milk and/or using the Golden Guernsey Milk Products trademark.

How to Enter the Contest

1. Submit your form
 - Fill out the entry form for the Golden Guernsey Milk Products Contest. This form can be found on the American Guernsey Association website under National Convention Contests.
 - Entries must be submitted to the American Guernsey Association office (1224 Alton Darby Creek Rd. Columbus, Ohio 43228 or ralden@usguernsey.com) by June 15, 2026. Entries can also be made online at goldenguernseydairy.com
2. Ship Your Entries
 - Entries should be shipped to **Double Tree by Hilton Syracuse 6301 State Route 298 East Syracuse, NY 13057 . Attn: Linda Benn Hold for Nat'L Guernsey Convention. Please label "REFRIGERATE UPON ARRIVAL"**. Please use proper shipping methods for each product. If you are using wet ice, please wrap and seal twice to prevent leakage. Please include an entry form with your product information in the package. Overnight shipping is recommended. All entries must ship prepaid. Entries may also be brought to the Convention by entrants so long as they are received at appropriate temperature by June 30. All entries must arrive by June 30, 2026.

Entry Rules

- All entries must be submitted by a company/manufacturer of 100% Golden Guernsey Milk Products.
- There are no restrictions on the number of entries per company.
- Contest entries can be submitted by any Golden Guernsey Milk Products manufacturer in North America. International processors are also eligible to enter the contest.
- For all contest categories the evaluator reserves the right to move product that appears misclassified into the appropriate product class or products may be discarded if they were not received at the correct temperature threshold.

Classes

1. Cheese - Hard
2. Cheese - Soft
3. Butter
4. Fluid Milk - White
5. Fluid Milk - Chocolate
6. Fluid Milk - Flavored
7. Half and Half/Creamer
8. Cream
10. Yogurt
11. Ice Cream - Vanilla

Product requirements

Cheese Entries -

Cheeses must be submitted in at least 8 oz.

Butter Entries

Butter entries must contain at least 1 pound.

Fluid Milk

Each entry must contain at least 2 half Gallons.

Half and Half/Creamer

Each entry must list product name and ingredients and must contain at least 2 quarts.

Cream

Each entry must contain at least 2 quarts.

Yogurt

Yogurt entries must contain at least 2 8oz containers or equivalent. There are no restrictions on fat level or sweetener.

Ice Cream

Entries must contain at least 1 half gallon of product and be received frozen.

Important Contest Dates

- Entries forms are due to the AGA – June 15, 2026
- All Entries must be shipped (or brought to Convention) - to be received June 30, 2026
- Contest results announced – July 4, 2026
